Extractables

Compounds can be pulled out of a container or product when exposed to extreme solvents and/or conditions such as elevated temperatures.

Leachables

Compounds originating in container closures that seep into a finished product. Leachables can affect products under standard conditions but can be traced to monomers, polymer additives, or release agents in the manufacturing process.
